

## Live! Casino Pittsburgh Live!-o-Lantern Pumpkin Carving Contest

## Official Rules

Casino Facebook page at TBD Eastern Time ("ET") on Monday, October 4, 2021 and ends at 11:59PM ET on Monday, October 25, 2021. ("Promotional Period"). Any entries received prior to or after this Promotional Period will not be eligible to enter or win. Sponsor's computer is the official time keeping device for this Contest. Three (3) winners will be notified via email or phone call on or TBD and each potential winner will have two (2) days to respond to Sponsor and provide all required documentation to claim the prize. Upon submitting an eligible post, you will be automatically entered into the Contest. By entering the Contest, you agree that Sponsor may contact you via email, phone call or social media, including on Facebook by sending you a direct message, tagging you, posting to your social media page or naming you on Sponsor's social media page. All potential winners are subject to verification before any prize will be awarded.
